OPERATIONS ORDER 10-214: Authorization of Direct Liaison Authority (DIRLAUTH) to the Family Morale, Welfare, and Recreation Command (FMWRC) Gifts and Donations Program (U)

(U) Time Zone Used Throughout the Order: Zulu.

1. (U) **SITUATION.** The Family Morale, Welfare, and Recreation Command (FMWRC) Gifts and Donations Program provides services to assist Army installations worldwide in facilitating the process and acceptance, and coordinating the delivery and distribution of Gifts and Donations for Soldiers and their Families and Nonappropriated Fund Instrumentalities (NAFI). The Gifts and Donations Program additionally acts as the bridge between the donor and Garrison Commander to gather and provide specific information required to execute a donation in accordance with the intent of the donor. The Gifts and Donations Program processes donations earmarked for several different Garrisons under one action to increase efficiencies and reduce redundancies and effort by the donor and the garrison. This corporate level approach requires the need for Garrisons to provide information that facilitates coordination of the donation. Additionally, many donations are offered with very short timelines; i.e., cruises, time shares, tickets to sporting events, etc. Quick action to gather data, provide info to donors and coordinate logistics is needed for success. Due to the unique nature of actions that need to be accomplished, the Gifts and Donations Program requires direct liaison authority to coordinate with the Regions and Garrisons.

2. (U) **MISSION.** NLT 30 days from release of the order, U.S. Army Installation Management Command authorizes direct liaison authority (DIRLAUTH) between the Commanding General, FMWRC (Gifts and Donations Program), and Region Directors/Garrison Commanders in order to execute the planning and coordination process of any potential donation in support of Soldiers and Families.

3. (U) **EXECUTION.**

3.A. (U) **Commander's Intent.** My intent is for the FMWRC Gifts and Donations Program to accomplish all required planning and coordination processes and taskings in a timely and efficient manner in support of our Soldiers, Families and Civilians. I expect DIRLAUTH to bring efficiency and effectiveness in the accomplishment of the Gifts and Donations Program through direct communication with Regions/Garrisons to provide the services and support for all aspects of the gifts and donations process.

3.B. (U) Concept of Operations. Upon release, Commanding General, FMWRC (Gifts and Donations) exercises direct liaison with Regions Directors and Garrison Commanders solely for the purpose of coordinating actions related to the Gifts and Donations Program.

3.C. (U) Tasks to Subordinate Units.

3.C.1. (U) IMCOM Region Directors.

3.C.1.A. (U) Exercise DIRLAUTH with CG, FMWRC to coordinate actions related to the Gifts and Donations Program.

3.C.1.B. (U) Direct Garrison Commanders to exercise DIRLAUTH with CG, FMWRC coordinate actions related to the Gifts and Donations Program.

3.C.2. (U) CG, FMWRC.

3.C.2.A. (U) Exercise DIRLAUTH with Region Directors and Garrison Commanders to coordinate actions related to the Gifts and Donations Program.

3.D. (U) Coordinating Instructions:

3.D.1. (U) This order is effective NLT 30 days from release.

3.D.2. (U) At the direction of the lead command or staff element, participate in or take action in support of activities, meetings, and/or conferences required to successfully execute this order.


